PONTOON RENTAL AGREEMENT**

- ___1. I accept, for use of an 11 people capacity pontoon boat with a 4 stroke Yamaha outboard, as is. I accept full responsibility for the equipment while in my possession. I understand there is **NO COOKING** allowed on the pontoon.

- ___2. I will be responsible for the full replacement value and reimbursement of any equipment rented under this agreement, not returned to ALW. This includes propeller repair/replacement, lifejackets, throwable, paddle, anchor, bungee lines, sand bar poles and turn bars.

- ___3. I agree to return this equipment **BY THE AGREED TIME AND IN CLEAN CONDITION TO AVOID ANY ADDITIONAL CHARGES**. Units returned not to be considered clean by ALW will result in a \$75.00 cleaning fee.

- ___4. I understand that there are inherent and other risks involved in boating for which this equipment is to be rented, that injuries are a common and ordinary occurrence of the sport and I freely assume those risks.

- ___5. I hereby release ALW and its owners, agents, and employees from all liability for damage and injury to myself or to other people and or property resulting from negligence and use of this equipment accepting myself the full responsibility for any, and all such damage or injury in which may result. I agree to operate under the Michigan boating laws.

- ___6. All instructions on the use of this pontoon have been made clear to me. Boat driving instructions have been given to me and I understand the functions of the equipment.

- ___7. No **OPERATIONS** of this boat from **DUSK TO DAWN**, unless overnight rental.
